

Veri-Tax™ eSign Consumer Guide

Revised 1.28.2020

Plaza Home Mortgage[®] is working with us on your home loan and they will be sending you a request via their service provider, Veri-Tax, by email asking you to review and digitally sign a 4506-T form so they may request a transcript of your submitted tax return from the IRS.

The email will be sent from Veri-Tax, and come from the email address info@taxverification.com, with the subject line 4506-T Form E-Sign Request.

Here's how to eSign and return your 4506-T form

Once you receive the email from Veri-Tax requesting your signature, please follow these instructions:

1. Carefully read the instructions in the email, and then select the "Click here to review and esign" link to open the document.



- 4. Click on the signature section at the bottom of the form to sign.



8	after June 15th. There are no availability restrictions on prior year requests. Most requests will be processed within 10 business days. Form W-2, Form 1099 series, Form 1096 series, or Form 5496 series transcript. The IRS can provide a transcript that includes data from these information returns. State or local information is not included with the Form W-2 information. The IRS may be able to provide this transcript information for up to 10 years. Information for the current year is generally not available until the year efter it is filed with the IRS. For example, W-2 information for 2011, filed in 2012, will likely not be available from the IRS until 2013. If you need W-2 information for retirement purposes, you should contact the Social Security Administration at 1-600-772-1213. Most requests will be processed within 10 business days.




5. Enter your name in the text field, then click the "Apply" button.

- 9. Once you have completed this process, the request will be sent to the IRS. The IRS will then send the requested tax forms directly to Plaza for processing.
